Privacy Policy

With this privacy policy we, Profital Group LLC, hereinafter referred to as the "the Company" would like to inform you about our use of personal data. We realize the importance of protecting the personal data of the user and therefore adhere to the applicable data protection laws.

Controller/Contact

Definition

Personal data means any information concerning the personal or material circumstances of an identified or identifiable individual. This includes information such as your name, your address, your phone number and your email address.

Personal data that the Company processes

The Company collects and processes several types of personal data, all depending on the situation. Examples of such personal data are names, addresses, e-mail addresses, phone numbers, IP-addresses, or other information that you provide within the framework of Company's service.

Purpose of processing personal data

Transfer of personal data and disclosure of personal data

Data Storage

We have implemented comprehensive technical and organizational measures to protect your data against possible threats, e.g. unauthorized access, unauthorized disclosure, alteration or distribution, or loss, destruction or abuse. In order to protect your personal data from unauthorized access by third parties during a transmission, the transmission of data might be protected by SSL-encryption, a standardized encryption method for online services.

Log Files

If you visit our website, your internet browser automatically transfers log information to our server which is stored in log files, the so-called server log files. The log files include the following data:

- URL of the referring website
- Date and time of request

- IP address of the accessing computer
- Website(s) that the user accesses
- Volume of data transmitted, type of your browser and its version
- Operating system, name of internet service provider
- Information whether the processing request was successful

The log files will be evaluated in an anonymised form in order to improve our website and make it more user-friendly, to find and correct mistakes and to manage the servers' load. In order to evaluate the log files, we use the programs "LogEntries" and "Papertrail". It may occur that your usage data will be transferred to the servers of the companies that provide such programs. We need this data in order to ensure a secure and stable connection between you and us. We also use this data to make the user experience on our website more enjoyable.

Cookies

We need cookies in order to provide certain services on our website. Cookies are small files that your browser stores on your device in a particular directory. Cookies enable us to e.g. ascertain whether you have already accessed a website before. Most browsers automatically accept cookies. In your browser settings, you can deactivate the storage of cookies or require your express consent before a cookie is placed. You can also delete cookies from your hard drive at any time. Web Analytics

In order to optimise this website and our services, we use Google Analytics, a web analytics service provided by Google, Inc. ("Google"). Google Analytics uses "cookies", which are text files placed on your computer, to help the website analyze how you use this website.
